This is a three phase competition consisting of Dressage, cross country jumping, and stadium jumping with the lowest combined score to win.

Dressage tests: Found on the USEA website <http://useventing.com/competitions/dressage> and the intro test on the USDF website <https://www.usdf.org/downloads/forms/2019.asp> We offer a small court sand arena 20m x 40m.

Cross country jumps will be in a grass field and some through a wooded area and introducing downhill+uphill track into a quarry with fun and inviting jumps.

Stadium phase will be in our lovely covered arena.

Clothing: Breeches, boots and helmet required for all phases. Medical armband and protective vest required for the jumping phase. Formal clothing and braiding optional.
